The Network will strive to initiate, encourage, support, implement and monitor the OGP process and encourage authorities and other institutions to increase their transparency, accountability and openness to participation.

The role of the network is to mobilize and coordinate civil society advocacy on OGP issues.

The network is informal and open to the participation of civil society organizations operating in different fields and advocating for civic participation in public policy making, transparency and accountability of the authorities. The process of network formation is led by the Initiative Board of 10 CSOs¹, which will operate temporarily until the network structure is established.
